ALTERNATE HIKE: Due to boat schedule changes, Catalina Island Hike has been cancelled.

Departure times from Catalina Express are either 6:15am or 10:00am returning time 3:45pm or 7:30pm. Catalina Island Adventure has been cancelled for this week. I talked to Jim Carlin, he suggested an alternate hike, I talked to Mike Gessner to let him know, since he, Kathy, Alice and Ally had made hotel reservations.

Directions; we reach the roadhead by driving Pacific Coast Highway to Corral Canyon Road, a little over 2 miles west of Malibu Canyon Road, turn right at the Union Station and drive up to the first bend in the road where you will see the entrance to Solstice Canyon Park on your left. Enter and follow the (new) road to the parking lot.

The hike: The trail drops south into Solstice canyon meeting Old Solstice Road where we turn right continuing up-canyon. Soon we'll pass the 1865 Matthew Keller house, believed to be the oldest house in the Santa MonicaMountains. After a few more minutes, we will pass through the Fern Grotto, ending at the ruins of the Robert's Ranch House which burned in 1982.

At the grotto/waterfalls/Robert's Ranch house, there are 3 options:

- a. Return via the Old Solstice Road trail (the way we came)
- b. Continue on the Rising Sun Trail along the east rim of Solstice Canyon back to the parking lot via the TRW building.
- c. Continue on the Sostomo Trail which does the Deer Valley Loop, then return via Old Solstice Road.

Option c. was VERY overgrown during Ron Obert's hike, and is probably even worse now. It is not recommended.
